**I.
Subject and Conditions of the Agreement**

1. The subject of this Agreement is the provision of a financial donation to the Donee, at the Donee’s request, amounting to CZK⁴, as the Donor’s contribution for the payment of the Donee’s accommodation in an accommodation facility situated in the territory of the Karlovy Vary Region.
2. The Donee accepts the donation.
3. The donation has been approved by Resolution of the Board of the Regional Council No. RK .../.../20.
4. The Donee represents that:
 - a) All details given in the above electronic request are true.
 - b) In compliance with Act No. 106/1999 Coll. on free access to information, as amended, and in compliance with Act No. 110/2019 Coll. on personal data processing, the Donee consents to the processing of data (the name and surname, address, date of birth) and personal data of the above representative of the applicant, who requests that a donation should be provided from the budget of the Karlovy Vary Region, for the internal need of the Karlovy Vary Region, in connection with handling the request for a donation from the budget of the Karlovy Vary Region. The applicant also consents to processing a database of applicants for the internal needs of the Karlovy Vary Region and for publishing the information about them on the website of the Karlovy Vary Region.
 - c) The applicant represents that the persons that use the accommodation together with the applicant agree that the applicant should also request a donation on their behalf.
5. The Donor and the Donee state that they have entered into this Agreement based on their free will, that they have read the Agreement and agree with the contents hereof. In witness thereof, they attach their signatures.
